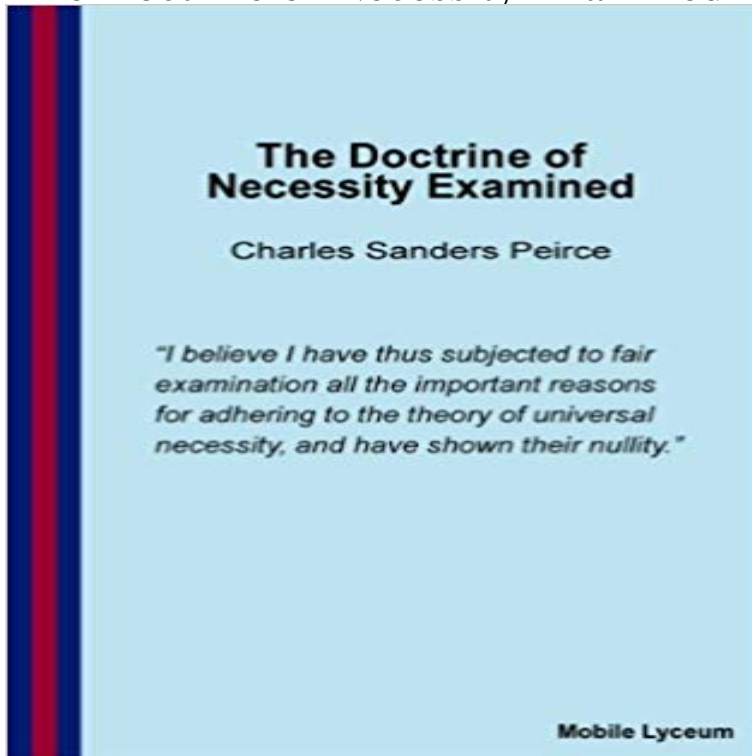


The Doctrine of Necessity Examined
