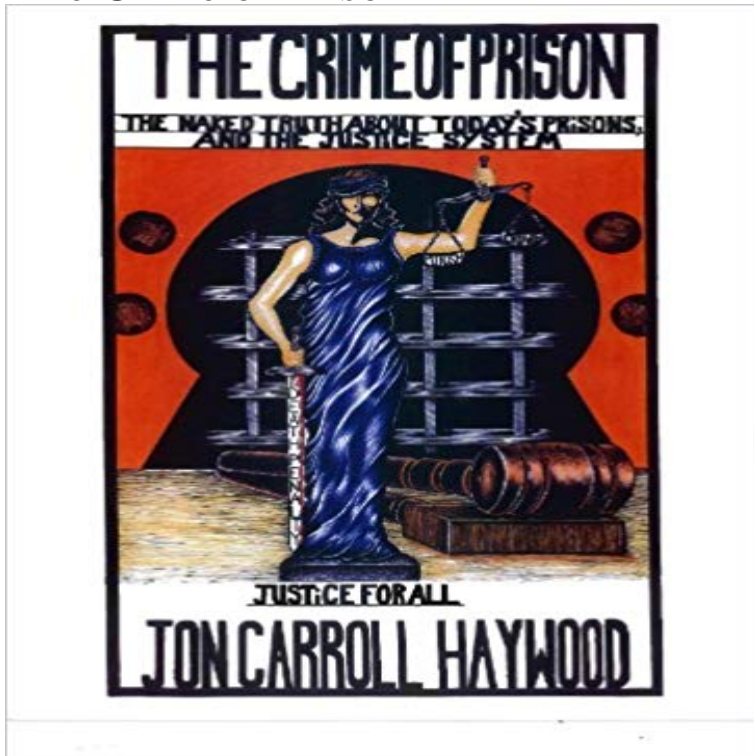


The Crime of Prison
