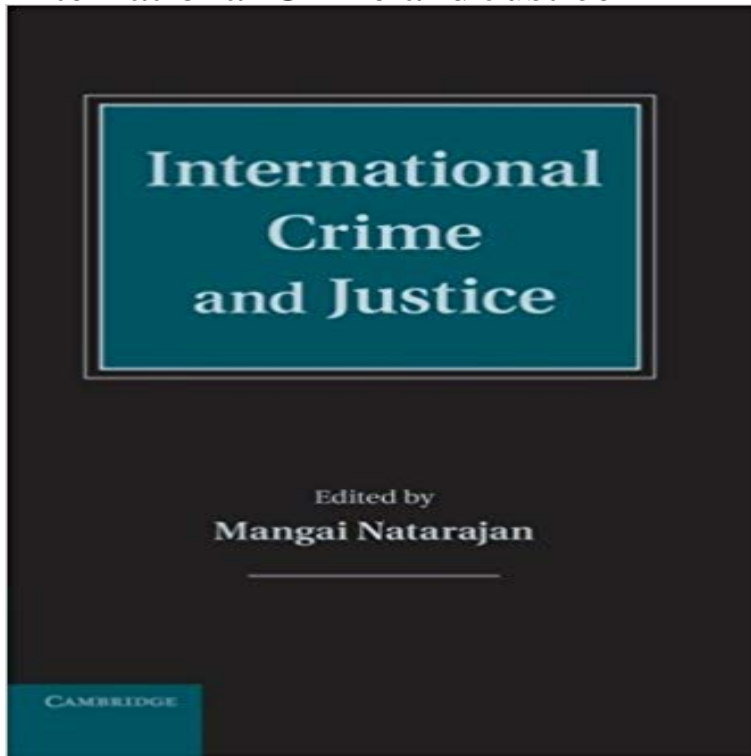


# International Crime and Justice
